- 1) L-1 bidder have to submit Bank Solvency Certificate of Rs. 10,00,000.00( Ten Lakhs Only) from the bankers.
- 2) All bidder applying in the category of MSME for exemption of tender fee/EMD should adhere to the following norms :-
  - (a) The Copy of MSME certificate should be compulsorily submitted. The MSME certificate for nature of work/services should be in line with the services for which MSME certificate is submitted.
  - (b) If the bidder in this category declared qualifies to be L1, the bidder will required to submit performance bank guarantee as a security deposit for an amount of Rs. 2,00,000.00 ( Rupee Two Lakhs Only). Bank Guarantee will be returned after the expiry of Contract.
- 3) As a token of acceptance to terms and conditions of the tender document the bidder should submit tender document with stamp and signature affixed on all the pages.
